  - a. Financial Report/Approval of Bills

Total funds are at \$1,177,627.94, with Library Fund at \$505,272.46; Building Fund at \$133,590.01, and New Construction Fund at \$538,765.47. Expenditures from the Library Fund are \$165,335 YTD, against a target of \$183,303, so our spending is under control thus far. Revenues are significantly behind projection: (Please note that I discovered a mis-calculation in my spreadsheet, and it should show that we are \$48,500 short of revenue and not just the \$24,000 or so that I stated.) We do not know why the county does not show that we have that offsetting \$23,500 transfer in from fund balance--- the BCB representative's explanation was not clear to us. But in addition, we are still short some \$20,000 in Tax revenues, and penal fines are running almost \$5,000 behind target so far in the year. We are going to seek explanations from equalization department and Court Administrator to see if there are pending revenues that we can count on. We can now consider the "cash pooled" in our 271 and 471 balance sheets to represent the value of the asset we now have at Chemical Bank.
